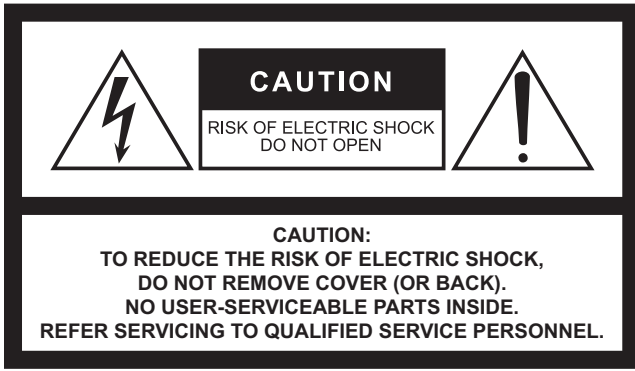

简介

要全面应用RMio64-D的强大功能和出色性能、延长产品的可靠使用年限，操作前请认真阅读本说明书。

功能特点

RMio64-D是一台数字接口箱，可以在Dante网络和MADI兼容设备之间传输最多64路输入/64路输出数字信号。将Dante和MADI设备相连接，本产品即可在多种用途中应用，如广播、现场录音和后期制作。另外，本设备的控制方式已经与Yamaha Dante兼容设备全面实现了无缝整合。

- 支持Dante和MADI的冗余功能，从而提供极高的可靠性。
- MADI输入和输出中配置了采样率转换器（SRC）。
- 信号可以从MADI光纤环出到同轴，或者是从同轴发送到光纤（MADI Split）。
- 增强了与Steinberg Nuendo软件的结合使用能力，如通过Nuendo Syncstation得到高精度的同步时钟以及对信号的直接监听。

机架安装的预防措施

本机额定在0到40°C环境温度范围内操作。将本机同其它RMio机种及其它设备安装到EIA标准机柜时，内部温度可能会超过指定的上限，从而造成性能下降或故障。在机柜中安装本设备时，请始终按照下列要求操作，避免热积聚：

- 在机架中将本机与可产生大热量的功率放大器安装在—起时，请在RMio和设备之间保留1U以上的空间。也可敞开空余空间，或安装合适的通风面板尽量减少热量的聚积。
- 为了确保足够的空气流通，请将机架背面敞开并将其放置在离开墙壁或其它表面10cm以上的位置。如果已安装了风扇组件，封闭机柜后面可能会达到更好的冷却效果。有关详细说明，请参见机架和/或风扇组件的使用说明书。

固件升级

本产品能够升级固件，以利提高操作性、增加功能并排除可能的故障。以下两种类型的固件对应本设备使用。

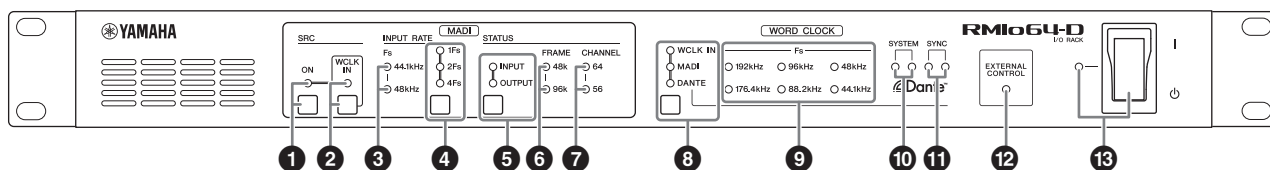

控制器和功能

前面板



1 MADI [SRC ON]指示灯 MADI [SRC ON]键

打开和关闭MADI SRC（采样率转换器）（打开时指示灯亮起）。

2 MADI [SRC WCLK IN]指示灯 MADI [SRC WCLK IN]键

选择后面板上MADI[WCLK IN FOR SRC]接口使用的字时钟是否作为MADI SRC时钟使用。（使用时指示灯亮起。）

如果没有检测到可用的字时钟输入信号，该指示灯会闪烁。

3 MADI [INPUT RATE Fs 44.1kHz]指示灯 MADI [INPUT RATE Fs 48kHz]指示灯

设备自动检测到MADI输入信号为44.1 kHz或48 kHz时这些指示灯会相应打开。如果没有检测到可用的MADI输入信号，这些指示灯都会熄灭。

4 MADI [INPUT RATE 1Fs]指示灯 MADI [INPUT RATE 2Fs]指示灯 MADI [INPUT RATE 4Fs]指示灯 MADI [INPUT RATE] 1Fs/2Fs/4Fs键

结合着MADI输入采样率选择1Fs (1x)，2Fs (2x)或4Fs (4x)。例如，对于192 kHz (4x 48 kHz)的MADI输入采样率，要确认MADI [INPUT RATE Fs 48kHz]指示灯为打开状态，然后选择[4Fs]。

注

如果选择[2Fs]，本设备会自动检测MADI输入信号的架构格式（48 kHz/96 kHz）。

5 MADI [STATUS INPUT]指示灯 MADI [STATUS OUTPUT]指示灯 MADI [STATUS] INPUT/OUTPUT键

选择要显示MADI输入信号还是MADI输出信号信息（架构格式/通道数量）。

注

您可以用该键锁定面板，防止误操作（第14页）。

6 MADI [STATUS FRAME 48k]指示灯 MADI [STATUS FRAME 96k]指示灯

显示MADI输入信号或输出信号的架构格式。在44.1 kHz和48 kHz时，[STATUS FRAME 48k]指示灯会亮起。在88.2 kHz和96 kHz时，[STATUS FRAME 96k]指示灯会亮起。如果没有检测到可用的MADI输入信号，这些指示灯都会熄灭。

注

如果没有检测到可用的MADI输入信号，MADI输出信号会设定到48 kHz/64通道。

7 MADI [STATUS CHANNEL 64]指示灯 MADI [STATUS CHANNEL 56]指示灯

显示MADI输入信号或输出信号的通道数量（64或56）。如果没有检测到可用的MADI输入信号，这些指示灯都会熄灭。

注

如果没有检测到可用的MADI输入信号，MADI输出信号会设定到48 kHz/64通道。

8 WORD CLOCK [WCLK IN]指示灯 WORD CLOCK [MADI]指示灯 WORD CLOCK [DANTE]指示灯 WORD CLOCK WCLK IN/MADI/DANTE键

选择字时钟来源。

WCLK IN	使用从后面板上的[WORD CLOCK IN]接口输入的字时钟信号。如果没有检测到有效的字时钟信号时，该指示灯会闪烁。
MADI	使用MADI输入信号的字时钟。如果没有检测到有效的字时钟信号时，该指示灯会闪烁。
DANTE	使用来自Dante网络的字时钟。

9 WORD CLOCK [Fs]指示灯

显示本设备使用的字时钟频率。如果字时钟没有同步，指示灯会闪烁。

10 Dante [SYSTEM]指示灯

显示本机的操作状态。

绿 (指示灯亮起)	本设备工作正常。
绿 (指示灯闪烁)	固件升级正在进行中。
红 (指示灯亮起)	本设备的内存不能正常工作。
红 (指示灯闪烁)	Dante模块发生错误。

11 Dante [SYNC]指示灯

显示Dante网络和本机之间的同步状态。

绿 (指示灯亮起)	设备在Dante网络上作为 follower 工作。
绿 (指示灯闪烁)	设备在Dante网络上作为 leader 工作。

橙 (指示灯亮起)	Dante网络正在同步。
橙 (指示灯闪烁)	设备与Dante网络不同步。

12 [EXTERNAL CONTROL]指示灯

有些参数不能由RMio64-D设备进行设定。该参数需要由外部遥控设定。当RMio64-D设备不能成功设定参数时，该指示灯亮起。

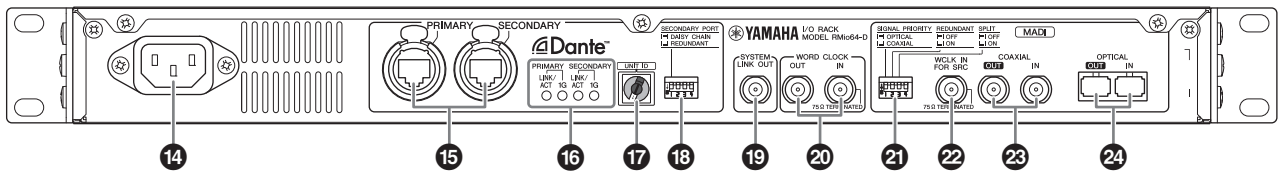

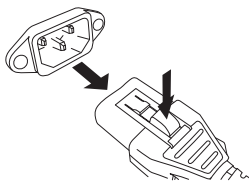
14 AC IN (交流电输入)接口

将电源线连接到这里。先将AC电源线连接到RMio4设备，然后将电源线插头插入AC电源插座。附带的AC电源线带有可锁紧的V-lock装置，可以防止电缆的意外脱落。将电缆插头完全插入到底，直到牢固锁紧。

连接或断开电源线时，请确保关闭设备电源。

15 Dante [PRIMARY]接口

Dante [SECONDARY]接口

这些是etherCON (RJ-45) 接口，用于连接到Dante网络。

- 使用STP (屏蔽双绞) 电缆可防电磁干扰。确保插头的金属部分和STP屏蔽线之间使用导电胶带或类似方式可靠连接，导电性能良好。
- 只能连接Dante兼容设备或GbE兼容设备 (包括计算机)。
- 可使用最长100米 (理论值) 的电缆。

- 16 Dante [PRIMARY LINK/ACT]指示灯**
Dante [PRIMARY 1G]指示灯
Dante [SECONDARY LINK/ACT]指示灯

 显示应用Dante网络的传输状态。

LINK/ACT	如果以太网线连接正确，它们会快速闪烁。
1G	当Dante网络以Giga-bit网络形式工作时，这些指示灯会亮起。

17 Dante [UNIT ID]旋转开关

设定该设备的ID。UNIT ID的设置范围为十六进制0到F。如果有多台需要ID设置的Yamaha Dante兼容设备已连接在同一网络中，就需要为每台设备设置不同的ID。确保在本机电源关闭状态下改变旋转开关的设置，否则ID设置将不会产生作用。

18 Dante DIP开关

用来改变本设备的设置。确保在本机电源关闭状态下改变DIP的设置，否则ID设置将不会产生作用。详情请参见“连接Dante兼容设备”（第11页）和“恢复出厂设置”（第18页）。

19 [SYSTEM LINK OUT]接口

BNC接口用于连接Steinberg Nuendo SyncStation的AES 2 IN接口。该连接可提供本机和Nuendo之间超精准的时钟同步。

不连接Nuendo SyncStation时，Dante输入信号的2个通道会以AES/EBU信号输出。将AES/EBU兼容设备连接到这个接口，可使Dante信号转换为AES/EBU信号，并输出。默认设置下，Dante通道1和2用于输出。可以通过遥控方式来更改输出通道。详情请参见“遥控”（第16页）。

20 [WORD CLOCK OUT]接口
[WORD CLOCK IN]接口

这些是BNC接口，用于发送和接收时钟信号。

21 MADI DIP开关

22 MADI [WCLK IN FOR SRC]接口

使用网络交换机的相关注意事项

在Dante网络中不要使用网络交换机的EEE功能 (*)。支持EEE功能的交换机，尽管可以自动调节两两之间的功耗设置，但仍有无法正确调节此类设置的交换机。设置不当时，在Dante网络中启用EEE功能，可能会导致不同步和断线。因此我们建议如下。

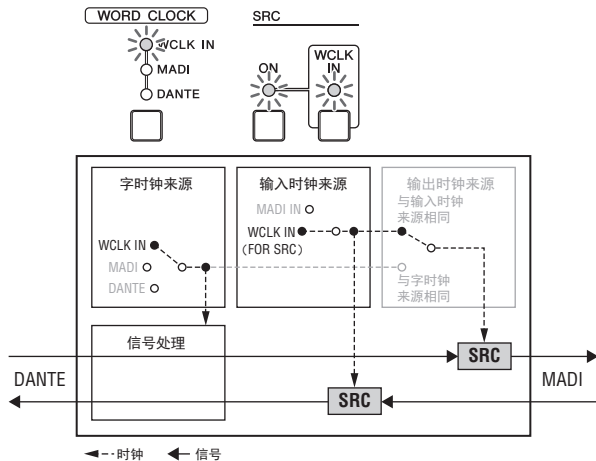

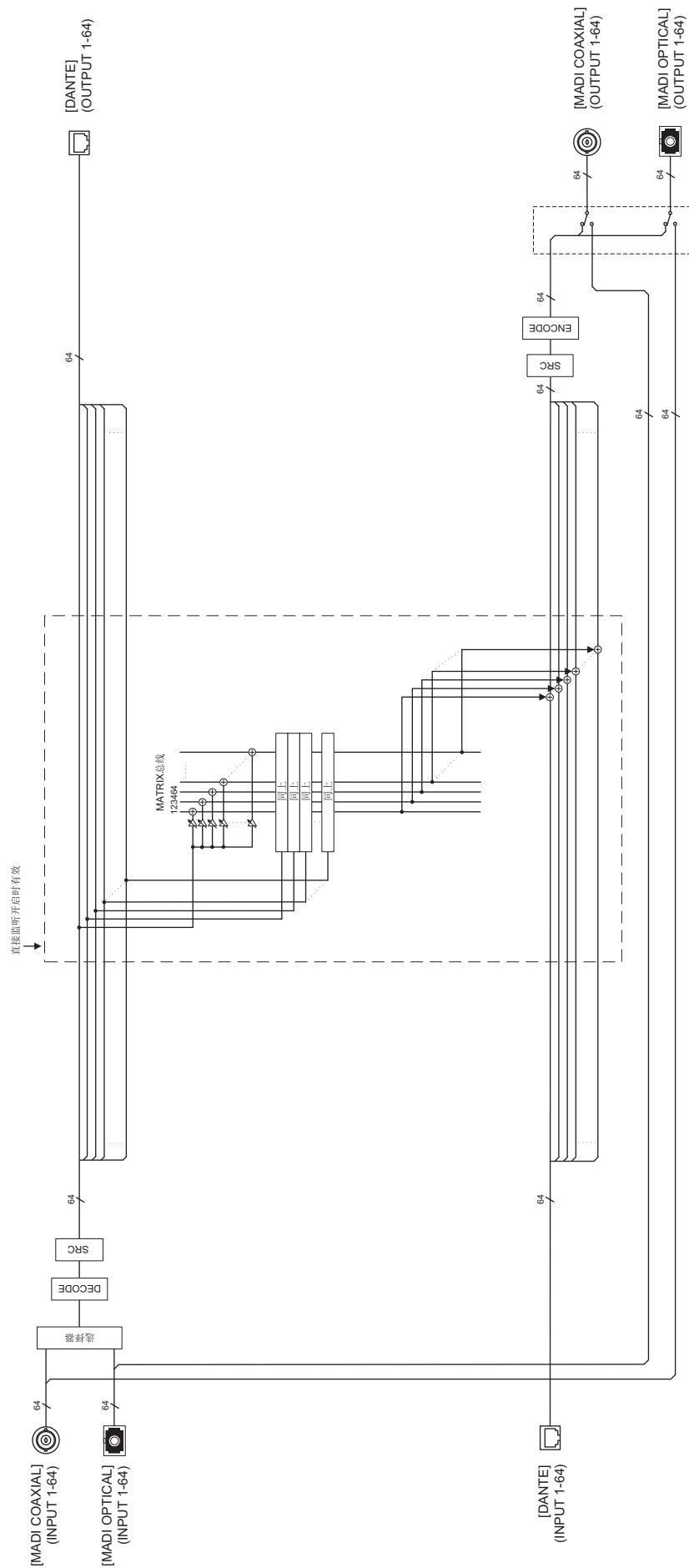

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.
